Financial Status

- Checking beginning balance October 1, 2024 \$6,300.82

- Beginning balance for CD # 3967 \$10,324.02
- Ending balance for CD # 3967 \$10,433.54
- Beginning balance for CD # 3969 \$5,172.87
- Ending balance for CD # 3969 \$5,231.38

Both our CD's reached maturity on December 22, 2024, and following board approval at the December meeting were successfully reinvested. The new interest rate on CD #3969 is 3.76%, previously 4.52%, and we have the option to renew for another 12-month term December 22, 2025. This CD accrued a total of \$231.38 in 2024. The interest rate for CD #3967 is 4.02%, previously 4.24%, and we have the option to renew for another 6-month term June 22, 2025. This CD accrued a total of \$433.54 in 2024.

Per the 1099-INT form we received from the bank, our investments in total accrued \$668.85 in interest income in 2024. Due to the issuance of a 1099-INT we may need to explore resources to file taxes as we do not yet have a 501c3 status/exemption.

Additionally, we are exploring options to accept online payments both for membership renewals and programmatic registrations.
